## **ORDINANCE # 2016-1**

## EAST VULCAN RECREATION AREA ORDINANCE

An ordinance to provide for certain rules and regulations pertaining to the operation of the East Vulcan Recreation Area for the better use and enjoyment thereof by all the citizens. In accordance with the provisions of Act 156 of 1917, Recreation and Playground Act, the Township of Norway ORDAINS:

**Section 1: Title:** This ordinance shall be known and referred to as the East Vulcan Recreation Area Ordinance.

**Section 2: Purpose:** It is the intent of the Norway Township Board that the following rules are established and all are expected to be followed:

- 1. The East Vulcan Recreation Area shall be closed from the hours of 10:00 p.m. 7:00 a.m.
- 2. No person shall remove, destroy, mutilate or deface posters, notice signs or markers.
- 3. No person shall use park for business or commercial purposes without prior written consent of the Norway Township Board.
- 4. Camping is not permitted.
- 5. Operation of cars, trucks, motorcycles, minibikes, ATVs, UTVs or snowmobiles, is limited to designated roads, trails or parking lots only. The rule does not apply to the caretaker of the park while performing official duties.
- 6. Horses or other riding/pack animals, or any animal drawn vehicle, is not permitted on this recreation area.
- 7. Any person engaging in any violent, abusive, loud, boisterous, vulgar, lewd, wanton, obscene or otherwise disorderly conduct is cause for removal from the park.
- 8. No person shall deposit refuse or waste material which originated outside the park in receptacles provided for park use.
- 9. Dogs or domestic pets must be on a leash not to exceed 6 feet in length. The owner shall see to it that any feces expelled by their animal shall be cleaned up immediately by the person in control of the animal.
- 10. No person shall discharge firearms, firecrackers, rockets, or any other fireworks within said park.
- 11. No person shall have in their possession any alcoholic beverage, or illegal drugs while residing on the park property.

**Section 3: Severability:** The provisions of the ordinance are hereby declared to be severable, and if any clause, sentence, word section, or provision is declared void or unenforceable for any reason by any court of competent jurisdiction, it shall not affect any portion of this ordinance other than said part or portion thereof.

**Section 4: Repeal:** All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed, except that this Ordinance shall not be construed to repeal any provision in the applicable Joint Zoning Ordinance or Building Codes.

**Section 5: Effective Date:** This ordinance shall take effect 30 days following its publication after adoption by the Norway Township Board.
