

Norway Township Public Budget Hearing, March 10, 2026

1. Meeting called to order at 5:00 p.m. Pledge to the flag recited.
2. Members present: Don Byczek, Supervisor; Joyce Giuliani, Clerk; Brian Pellegrini, Trustee and Dave Solda, Trustee. Absent: Jeff Edwards, Treasurer
3. Approve agenda: motion to approve the agenda as presented was made by Pellegrini, second by Solda. All ayes. Passed 4-0.
4. Citizens Time: None
5. NEW BUSINESS:
 - a) Approve 2026/2027 Budget: final budget was reviewed. Motion was made by Giuliani, second by Pellegrini, to approve the final budget as presented. Roll call vote: Ayes –Byczek, Giuliani, Pellegrini, Solda. Nays: None. Absent – Edwards. Passed 4-0.
 - b) Approve 2026/2027 General Appropriations Act. Motion was made by Pellegrini, seconded by Solda, to approve the 2026/2027 General Appropriations Act as presented. Role call vote: Ayes – Solda, Giuliani, Pellegrini, Byczek. Nays – None. Absent – Edwards. Passed 4-0.
 - c) Approve Resolution 2026-1 Establishment of Regular Board Meeting Time and Place: Motion was made by Giuliani, second by Solda, to approve Resolution 2026-1 as presented. Role call vote: Ayes: Giuliani, Solda, Byczek, Pellegrini. Nays: None. Absent: Edwards. Passed 4-0.
 - d) Approve Resolution 2026-2 Establish Norway Township Pay Rates, Salary Schedules and Reimbursement: Motion was made by Solda, second by Pellegrini, to approve Resolution 2026-2 as presented. Role call vote: Ayes: Solda, Byczek. Nays: Giuliani, Pellegrini. Absent: Edwards, Tie vote 2-2. Board members disagreed on the amount of bonus money to be given to summer laborers due to them now being eligible for sick leave payout. In past years a \$500 bonus was given and Pellegrini and Giuliani proposed only a \$300 bonus due to the sick leave payout bringing the end of term amount close to \$500. With a tied vote, the \$500 bonus stands as it was for the last budget.
 - e) Approve Resolution 2026-3 Township Investment and Depository Designation Resolution: Motion was made by Solda, second by Giuliani, to approve Resolution 2026-3 as presented. Role call vote: Ayes: Byczek, Giuliani, Pellegrini, Solda. Nays: None. Absent: Edwards. Passed 4-0.
 - f) Budget Amendments for close out of current fiscal year: Motion to approve budget transfers as of March 31, 2026 to alleviate any deficiencies in individual activities was made by Byczek, second by Solda. Role call vote: Ayes: Solda, Pellegrini, Giuliani, Byczek Nays: None. Absent: Edwards. Passed 4-0.

7. Adjournment: Being no further business, a motion was made by Pellegrini, second by Giuliani, to adjourn the meeting. All ayes. Passed 4-0. Meeting was adjourned at 5:25 p.m.
