ATTACHMENT A

ADDITIONAL CONDITIONS FOR GRAVEL EXTRACTION

PARCEL # 22-004-013-033-00

3. Per Norway Township Zoning Ordinance, Section 1104, the site plan shall be certified (stamped) by a registered land surveyor, professional engineer or architect. Provide a stamped site plan.
4. Per State of Michigan Act 91, a Soil Erosion and Sedimentation Control (SESC) plan is to be submitted to the appropriate permitting agency. Provide a copy of the approved SESC plan and permit.
5. Per Norway Township Zoning Ordinance, Section 1108 Site plan completion guarantees are required. Provide as outlined in the ordinance.
6. Per Norway Township Zoning Ordinance, Section 1218 Access Management Standards, with the proposed access to continue to be through the Dickinson County Road Commission parcel, per J.4. Access Easement is to be recorded at the County Registrar of Deeds. Provide confirmation that the access easement meets the zoning ordinance requirements.
7. Clearing and Grubbing of the property: Trees, branches, slash and stumps that are being removed from the gravel pit area shall be fully removed from the property. Burying or burning on site is not permitted.
8. Buffer zones from all adjacent property lines shall be established per the Norway Township Zoning Ordinance. Buffer zones shall be staked in the field and approved by the Norway Township Zoning officer prior to commencement of any work.
